
## ESTHER 5 vs 1

- <sup>7</sup> Then Esther answered and said, My petition and my request is:
- <sup>8</sup> If I have found favor in the sight of the king, and if it pleases the king to grant my petition, and do my request, let the king and Haman come to the banquet that I will prepare for them, and tomorrow I will do as the king says.

<sup>9</sup> Then Haman went out that joyful day with a glad heart: but when Haman saw Mordecai in the king's gate, that he did not stand up or tremble before him, he was filled with anger against Mordecai.

<sup>10</sup> Yet Haman refrained himself: and when he went to his house, he sent for his friends, and his wife Zeresh.

- <sup>11</sup> And Haman recounted to them of the glory of his riches, and the number of his children, and all the events where the king had promoted him, and how he had advanced him above the princes and servants of the king.
- 12 Haman also said, Yes, Queen Esther let no one but me come with the king to the banquet she had prepared; and tomorrow I am also invited by her with the king.
- 13 Yet all this avails me nothing, when I see Mordecai the Jew sitting at the king's gate / why this one person who would not bow to the elite politician; next we see govt overkill.
- <sup>14</sup> Then Zeresh his wife and all his friends said to him, Have a gallows fifty cubits high be made, and in the morning ask the king to have Mordecai hanged on it: then go merrily with the king to the banquet. And the advice pleased Haman and he had the gallows made. / why; gallows 75 feet high... when you're just as dead at 7 feet; typical govt arrogance. Sounds like D.C. Someone needs to drain the swamp.
